

Rider & Requirements

To insure the best possible and punctuality of the show, the following conditions must be met by the Client. Please direct any questions regarding rider to Diego or Joel at **Downbeat**.

1. Location

Please send parking and loading directions for band. Exact location to event must be indicated; specific directions including a map is preferred.

2. <u>Power</u>

Client must ensure proper electrical access and capacity. The act or Downbeat cannot be held responsible for power interruptions. Venue will provide at minimum three separate 110v/20A circuits for band/audio exclusive use. Power must be no more than 20 feet from stage or act must be notified ahead of time. 50A generator would also work.

3. Stage

Performance area needed depends on group size. **19-Piece (16x30) or (12x40)**, **15-Piece (12x32)**, **10 or 11-Piece (12x24)**, **5 or 7-Piece (12x16)**, **and 3-Piece (12x8)**. If you need to change the performance size, please confirm with <u>booking@downbeat.agency</u>

4. Outdoor Engagements

If Artist is in direct sunlight, please note this can damage equipment and could prevent performance without covering. It is ultimately the decision of the Company to judge in good faith whether or not personal safety or property are threatened or compromised by threatening or inclement weather. Client understands and agrees that Company's services are not subject to cancellation for any weather-related reasons. If, in the opinion of Company, inclement weather or other adverse conditions arise, Client must provide adequate protection from the elements (i.e. rain, wind and excessive sunlight) via tent or other means. Client is responsible for any damages in any case where Client fails to provide adequate protection for Company's equipment. Client agrees to pay Company for any damaged equipment based on current market value plus any additional costs for overnight shipping to Company. If time permits, engagement can be moved to an alternate location, but performance time as stated on the face of this contract will not be extended to accommodate a change of venue. If the performance is canceled due to inclement weather, Company shall be entitled to full payment. Client understands and agrees that in the event Company must move to a separate location or venue off-property, Client agrees to pay an additional \$500.00 moving fee.

5. <u>Arrival</u>

Artist requires access to place of performance at least three prior to starting time for technical setup.

6. Hospitality & Meals

Please ensure the following is provided for band upon band arrival to event.

<u>Required:</u>

- A green room or area with tables and chairs for performers. If outdoors, tent or covering is needed.
- 2 cases of water or 48 bottles of water
- Case of assorted soda: Sprite, Coca-Cola & Diet Coke or access to bar at event
- (1) hot meal per person for event. Please confirm number of meals prior to event.
- Coffee & tea with cups; milk and sugar on the side is appreciated
- Box of cookies; chocolate chip preferred

If you would like us to provide our own break area, there is a cost and we will handle this for the talent. Please inquiry.

Optional but appreciated:

Bottle of wine (no preference) or case beer or access to bar at event.

7. Overtime

If and when agreeable, the time of the Performance may be extended at the hourly overtime rates. Rates are listed on contract.
